All bids must be submitted in a sealed envelope marked as "Air Ticket Quotation" addressed to the Offtg Director General, Bhutan Standards Bureau, Ministry of Industry, Commerce and Employment, Thimphu latest by February 13th, 2023, on or before 10:00 AM and will be opened at 10:30 AM on the same day.
- 2. If the flight or seat is not available on the above dates and sectors, you can quote earlier for an earlier date.
- 3. The purchaser reserves the right to reject a bid or all the bids if it is found non-feasible or if we lack the capacity to bear the cost resulting from your early or late quoted dates.
- 4. The rate should be quoted as per the sector given above and will be selected for the most economical and direct route. Evaluation will be done sector-wise based on the most economical and direct route.
- 5. Airline and seats must be confirmed while submitting the bids and submit confirmed itinerary details.
- 6. The validation of fares and availability of seats should be as per the details mentioned above.
- 7. The quoted rate should be inclusive of all applicable taxes and duties.
- 8. The successful bidder should submit a copy of the air ticket along with their invoices for payment.
